- 5. Photo submissions will become the property of Paintearth Economic Partnership Society and may be used for promotional and informational print and electronic publications
- 6. By submitting photos, entrants give authorization to Paintearth Economic Partnership Society to use their personal image and photo description in print and electronic publications
- 7. If the photograph contains any material or elements that are not owned by the entrant or which subject to the rights of third parties, or if any persons appear in the photograph, the entrant is responsible for obtaining, prior to submission, any releases and consents necessary to permit the exhibition and use of the photograph
- 8. Parents or guardians submitting photos under the age of 18 are giving full permission for Paintearth Economic Partnership Society to use the entries for promotional and informational print and electronic publications
- All entrants are required to sign a release for each photo submitted, which can be downloaded from the Paintearth Economic Partnership Society's website at <a href="www.paintearth.ab.ca">www.paintearth.ab.ca</a> Photos which are not accompanied by a signed release will not be considered eligible for entry into the contest
